Personal data we collect

Processing objectives

Safety measures

Computer

Archive

This archive is kept behind lock and key.

We will protect your data from unrestricted access, and processing to the best of our abilities, and with the help of reasonable technical, physical and administrative measures, e.g. antivirus, passwords, clean desk policy, restricted access to archive,...

Transfer to third parties outside of the EU

Rights

Access

 You have the right to access your data at any time, and the right to know what your data is being used for.

Correction, deletion, and limitation

Right to object
